(Tuition... continued)

- Please note that for new children registering, a \$60 deposit is due. This deposit is non-refundable if the child does not attend the center.
- > If an opening is being held for more than 2 weeks, a weekly non-refundable holding fee of \$50 will be required.
- ➤ If any child already enrolled in the center needs to be pulled out for any length of time, a \$50 non-refundable fee will be required for each week the opening is held, for up to three (3) months maximum.
- MCC hours of operation are 7:30 am to 5:30 pm, Monday through Friday. A half day is either morning or afternoon; morning sessions run 7:30 am to 12:30 am, and afternoon sessions run 12:30 pm to 5:30 pm. Late pick-up of children after 12:30 pm is subject to the same penalties as late pick-up at the end of the day. This charge is \$10 for the first 5 minutes and \$1 per minute thereafter. The \$10 fee is moved to 10 minutes if notice is called in.
- Monthly tuition is due on the 20th of every month. Late payments are subject to the following penalties:
 - ♦ 5% after the 20th of the month
 - ♦ If a family does not pay tuition (and late fee) by the 1st of the month, their child(ren) will be discharged from the program. To continue receiving childcare services, the family will have to re-enroll the child(ren), and they will be required to pay a registration fee of \$60.
 - ♦ A Flexible Payment Plan (weekly or bi-weekly payments) is available when arranged in advance with administration.
- > A 20% discount will be given for siblings of families with 2 or more children, and applied to the sibling with the lesser tuition. A 50% discount will be given to employees. These discounts are available only when payment is received in full by the 1st of the month.
- > A 5% discount will be given for payments paid in full for three months ahead.
- > Two weeks notification is required before child is considered withdrawn.

Holiday Closings:

- Memorial Day (the day observed)
- Independence Day (the day observed)
- Labor Day (the day observed)
- Thanksgiving Day and the Friday following
- ♦ The week of Christmas; Christmas Eve through New Year's Day (December 24-31).
- ♦ The center will re-open on the first business day after New Year's Day.

*Note: Monthly tuition rates have been adjusted to account for planned closures/ holidays.
